- 5. Neighborhood Update Krista McCraken
  - a. Lawncare company same for 2023- Renewed
  - b. 73 homes in Archdale have sold or are for sale Almost 10%!
  - c. 115 homes (or 15%) appear to be rentals this number will probably increase based on e. below
  - d. Dorchester County did a tax audit and ACA found approx. 115 properties whose tax rate changed. ACA notified those properties either by email or mail.
    - -John Trinkl did a rental verses owner because this topic was of interest and discussed at the very first general meeting since renters are not part of ACA inc. and the owners get the ACA inc. letter to join
    - -results showed some homeowners residents are taxed at the higher rate of 6% instead of the 4%
    - -sent a cost saving letter about the situation to notify these owners as a service from ACA inc.

- 3. New sidewalk going in front of neighborhood along Dorchester Road for wheelchair and safety issue
  - -side walk not done by DOT or Dorchester County
  - -Side walk is done by North Charleston
  - -side walk will be painted per code

- -storm debris pick up- right now you hull off yourself
- -need to get real cost of being double taxed city and county
- -need 100% of residents to agree to be a part of North Charleston
- -discussed that Dorchester County is not self-insured
